## Pandemic Guidance – Personal Care and Memory Care



Please note: physical distancing and mask wearing is required for all persons while in public. Vaccinated residents are not required to wear face masks while outside with small groups of other vaccinated people. Any communal activities are available for residents who are NOT Covid-19 positive or in quarantine.

Service Category	Green Phase
Banking Services	Resident can visit the bank, accompanied by staff member or per care plan.
Dining	Vaccinated residents may dine together at the same table without keeping physical distancing requirements.
	Unvaccinated residents must follow physical distancing requirements. All residents must wear face masks while not eating.
	Vaccinated residents may dine in the Apple Orchard Café, Hearthside Bistro, or Christopher's with other residents or vaccinated guests per care plan.
Family Gatherings	Families may have gathering on campus. Please see the front desk team for room reservation guidelines.
Gift Shop	Residents can visit the gift shop, accompanied by staff member or per care plan. Visitors may use the gift shop.
Hair Salon/Barber	Salon services available, subject to state guidelines.
Library	Residents can use library, accompanied by staff member or per care plan.
Life Enrichment/ Wellness	Life enrichment schedule resumes with appropriate physical distancing for the space in which the activity is being held. Residents may visit the fitness center, per care plan.
Living Branches Outings	Off-campus outings may continue. Vehicles can resume full occupancy, but all persons must wear face masks.
Off Campus Outings	Personal Care - Fully vaccinated residents (at least two weeks past second dose) may attend off-campus outings without needing to quarantine or Covid test upon return to campus.
	Memory Care – Fully vaccinated residents may attend low risk off-campus outings without needing to quarantine or Covid test upon return to campus. Low risk outings are defined as fewer than 10 vaccinated persons, or one household of non-vaccinated persons.
	Memory Care – Fully vaccinated persons may attend higher risk functions (family celebrations, etc.) but will need to be tested for Covid on day 4 and 11.
	Memory Care - Residents who are not fully vaccinated will be required to quarantine for 14 days if they leave campus for a high risk outing.

Pastoral Care/Worship	In-person services continue. Vaccinated residents do not need to follow physical distancing requirements. Visitors may attend worship services with residents, if space allows. Face masks must be worn.
Quarantine	Follow guidance from regulatory departments.
Screening	Everyone entering community must be screened at screening stations.
Visits – when resident or level of care is not in quarantine.	Private rooms may have a total of five persons in them – including residents. Shared rooms may have a total of four persons in them – including residents.
	Larger groups may visit in common areas or in outdoor areas. Outdoor visits are preferred, whenever possible.
	Visitors must wear a surgical face mask at all times, practice hand hygiene, and maintain physical distancing. Vaccinated visitors may eat with vaccinated residents when in a private space.
	Visitors do not need to schedule their visits, or provide negative Covid test results. Out-of-state domestic travelers or persons who have been on an airplane recently are allowed to visit without quarantining before arriving to campus. International travelers must follow CDC guidance.
	Visitors may reserve the guest rooms.
Volunteers	All resident volunteer duties may resume. Non-Living Branches residents who are fully vaccinated may resume volunteer duties.
