Pandemic Guidance – Residential Living



Please note: Attendance for group activities may be limited so we can allow for appropriate physical distancing.

Service Category	Green
Specific Areas	Community Lounges – With physical distancing and masks. Puzzle tables are in use.
	Library/ Computer Center – Computers can be used. Books do not need to be quarantined after their return.
	Pool Tables – Please disinfect before/after each game.
	Fitness Center – Must sign up. Must be able to ensure appropriate physical distancing. Vaccinated future residents may use the fitness center.
	Swimming Pool – Open for Residential Living residents, subject to current pool guidelines.
	Woodshop – One or two residents at a time; must sign up. (Dock Woods open when Oakwood Court is in green.)
Banking/Everence	To be determined in conjunction with Univest/Everence.
Cleaning Services	Private cleaning services can continue. For residents in apartments, cleaners will need to go through screening at front desk area. In cottages or villas, resident should ensure cleaners have no symptoms of COVID and wear mask while in their residence, or ask them to go to the front desk for screening. We recommend leaving your residence while the cleaning person is inside.
Dining	In-person dining resumes. Seating may be limited. Residents can dine at other Living Branches campuses, if desired.
	Vaccinated guests are allowed in the Apple Orchard Café, Hearthside Bistro, and Christopher's to dine with residents. Please note that means children under the age of 12 are not permitted in the dining venues at this time.
	Vaccinated residents are able to dine with other vaccinated residents not from the same household. Follow all posted guidelines regarding number of persons at a table.
Family Gatherings	Families may have gathering on campus. Please see the front desk team for room reservation guidelines.
Funeral/Memorial Services	Not occurring on campus at the present time.
Gift Shops	Persons who are visiting residents may use the gift shops; they are not open to the wider public at this time.
Hair Salon	Open for residents

Maintenance	Full scope of maintenance activities continue.
Moving Services	Persons moving into or out of Residential Living are able to do so with the use of moving companies or family assistance. See your social worker for more information.
Physician Services	Continue to be available in the wellness center per the physician's individual schedules.
Resident Activities	Resident activities continue. Vaccinated residents are not required to follow physical distancing guidelines. Face masks are required for Residential Living residents in community spaces.
Resident Volunteers	All resident volunteer duties may resume. Non-Living Branches residents who are fully vaccinated may resume volunteer duties.
Self-Quarantine	No longer required after ER visit or overnight stay in hospital. Please review the PA Department of Health website for information regarding quarantine after travel.
Trips (through Living Branches)	Vehicles can resume full occupancy, but all persons must wear face masks.
Visits – when resident or level of care is not in quarantine.	Residents are able to have visitors in their residences. Out-of-state visitors and overnight visits are allowed. Guest rooms are open for visitor reservations.
Worship Services	In-person services continue. Vaccinated residents do not need to follow physical distancing requirements. Visitors may attend worship services with residents, if space allows. Face masks must be worn.
