| Specific Areas | Community Lounges – Puzzle tables are in use. |
| | Library/Computer Center – Computers can be used. Books do not need to be quarantined after their return. |
| | Pool Tables – Please disinfect before/after each game. |
| | Fitness Center – Future residents who are up to date with Covid vaccinations may use the fitness center. |
| | Swimming Pool – Open for residents, subject to current pool guidelines. |
| | Woodshop – Please be sure to use the sign in sheet. |
| Banking/Everence | Banking services on campus according to schedule from Univest/Everence |
| Cleaning Services | Private cleaning services can continue. |
| | For residents in apartments, cleaners will need to go through screening stations. |
| Dining | In-person dining resumes. Seating may be limited. Residents can dine at other Living Branches campuses, if desired. |
| | Visitors are able to dine in the Apple Orchard Café, Hearthside Bistro, or Christopher's, regardless of vaccination status or age. |
| Exposure to Covid | If you are exposed to Covid, please contact your Residential Living director or nurse for information regarding Covid testing and isolation. |
| Face Masks | Optional for residents or guests in Residential Living areas. Face masks are still required for all persons when in Personal Care, Memory Care, and/or Health Care. |
| Family Gatherings | Families may have gathering on campus. Please see the front desk team for room reservation guidelines. |
| Funeral/Memorial Services | Able to occur on campus. All attendees must wear a face mask, regardless of vaccination status or whether they are a resident. |
| Gift Shops | Persons who are visiting residents may use the gift shops. |

| Maintenance | Full scope of maintenance activities continue. |
| Moving Services | Persons moving into or out of Residential Living are able to do so with the use of moving companies or family assistance. See your social worker for more information. |
| Physician Services | Continue to be available in the wellness center per the physician's individual schedules. |
| Resident Activities | Resident activities continue. |
| Resident Volunteers | All volunteer duties may resume. Volunteers must follow all Living Branches guidelines regarding Covid vaccination and face mask usage. Questions may be directed to the volunteer coordinator. |
| Screening at Entrances | Residential Living residents do not need to screen when entering the building at either Dock Woods or Souderton Mennonite Homes unless they will be visiting someone in Personal Care, Memory Care, or Health Care. |
| Trips (through Living Branches) | Vehicles can continue at full occupancy. Face masks are encouraged in vehicles. |
| Visits | Residents are able to have visitors in their residences. Out-of-state visitors and overnight visits are allowed. Guest rooms are open for visitor reservations. |
| Worship Services | In-person services continue. Visitors may attend worship services with residents. Residential Living residents are not required to wear face masks. Attendance does not need to be taken for Covid contact tracing purposes. |
